#### AT A GLANCE

- 25 formal submissions lodged between 1 July 2018 and 30 June 2019
- We appeared before various state and federal courts and commissions 8 times between 1 July 2018 and 30 June 2019
- We advocated in relation to a broad spectrum of issues within the following areas:
  - Workplace relations
  - Consumer law
  - Environmental policy and sustainability
  - Trading hours
- The majority of submissions were lodged with the federal or state governments in relation to proposed regulation.

#### NOTABLE ACHIEVEMENTS

- The NRA has engaged with 30,000 retail, quick service and hospitality businesses in relation to single-use plastic bag bans in Queensland, Victoria and Western Australia. The NRA Policy team created 3 dedicated web portals, engaging resources and signage and delivered 2 state-wide marketing campaigns reaching over 5 million people.
- Through effective advocacy, the NRA compelled the Fair Work Commission:
  - to re-examine the drafting of the determinations in the Saturday Penalty Rates case to remove ambiguity; and
  - revise its drafting of the Plain Language Redrafting Determination for the Retail Award with respect to overtime to minimise unintended consequences.
- The NRA was the only retail industry association to participate in all stages of the Fair Work Commission's Annual Wage Review and each of the state-based wage theft inquiries advocating against criminalisation of wage non-compliance.
- In addition to its Technical Standards, Loss Prevention, Leasing and HR committees, the NRA has also launched a national Sustainability Committee which brings together retailers, sustainability experts and government policymakers.
