	APCO has also published guidelines for determining whether something is single-use, unnecessary or problematic. This is a decision-tree not a specific definition:  "1. The packaging is partially or fully manufactured using a plastic of any kind (including bioplastics)?  2. The packaging is:  • Routinely disposed of after a single use or after its contents have been used or unpackaged, and typically not refilled.  • Not durable, washable, or routinely used for its original purpose multiple times before disposal.  If you answered no to any of the questions above, then the packaging is not classified as single-use plastic packaging. If you answered yes to both of the questions, the packaging is classified as single-use plastic packaging.
